



Leidos Announces Pricing of Senior Unsecured Notes Offering

RESTON, Va., Oct. 5, 2020 /PRNewswire/ -- [Leidos](#) Holdings, Inc. (NYSE: LDOS) ("Leidos"), a FORTUNE® 500 science and technology leader, today announced that its wholly-owned subsidiary, Leidos, Inc. (the "Issuer"), priced \$1,000,000,000 aggregate principal amount of 2.300% notes due 2031 (the "Notes") in connection with its previously announced private offering pursuant to Rule 144A and Regulation S under the Securities Act of 1933, as amended (the "Securities Act"). The Notes will be the senior unsecured obligations of the Issuer and will be fully and unconditionally guaranteed on a senior basis by Leidos. The Notes and the related guarantee will be structurally subordinated to the liabilities of Leidos' and the Issuer's existing and future subsidiaries.

The offering is expected to close on Oct. 8, 2020, subject to customary closing conditions.

The Issuer intends to use the net proceeds from the offering for general corporate purposes, including, among other things, to pay the outstanding balance on its 364-day term loan facility and a portion of the outstanding balance on its five-year term loan facility.

The Notes and the related guarantee will be offered in the United States to persons reasonably believed to be qualified institutional buyers pursuant to Rule 144A under the Securities Act, and outside the United States to non-United States persons in compliance with Regulation S under the Securities Act. The Notes and the related guarantee have not been registered under the Securities Act and may not be offered or sold in the United States without registration or an applicable exemption from the registration requirements.
